# **Project Description:**

McGough Construction on behalf of Sanford Health is currently soliciting bids for the Brain & Spine Neurology Renovation located within the existing lower level of the former Orthopedic Clinic at 2301 25<sup>th</sup> St. S Fargo, ND 58103.

The project consists of renovation of existing walls, floors, and ceilings, required for new finishes along with modifications to existing MEP infrastructure. Scopes of work we are accepting proposals for are: Glazing, Framing & Drywall, Cabinets & Countertops, Specialties, Acoustical Ceilings, Tile, Flooring, Painting, Window treatments, Sealants, Final Cleaning, etc.

Demolition of the space has already commenced in late August 2021. The expectation is that subcontractor/Suppliers will need to proceed with submittals, material procurement, and manpower to start immediately after notice of award. The construction completion is expected to be end of January 2022.
