provided a good living. One of his most memorable times on the job was about 25 years ago in Bemidji, MN. He and his fellow bricklayers dismantled the Paul Bunyan fireplace and relocated it to the inside of the visitors' center. He also worked on numerous buildings in East Grand Forks and the Como Park facilities in St. Paul. “It is still fun to see what Dad built,” says Vicki.

Anderson served as a business agent for nearly 20 years. In 1965 he started pulling a camping trailer which served the family well, when five years later, all seven headed to Washington DC for a union convention.

His two sons, Tom and Bob started as laborers and eventually became bricklayers working alongside him. Bob recently celebrated 40 years as a member.

Anderson stressed bricklaying was “part of life,” but they became bricklayers “at their own choosing”. Tom agrees. He became a BAC Local 1 member in 1986 and three years later he began his own business, Midwest Masonry in East Grand Forks and Bemidji.

Tom says he, his wife and two daughters have survived through thick and thin. Having spent a year in Arizona for work, he agrees with his dad that at times you have to travel to keep working. As a business owner, he says there is a lot of competition – some businesses have gone

Floyd Anderson sat comfortably next to his daughter Vicki as he spoke about his decades as a bricklayer. It is there, in his Apache Junction, AZ, home, that he spends at least seven months of the year before he travels back to Minnesota to enjoy the Midwest state's warmer months. He lives alone at the RV park and describes the Arizona desert climate as “so many more days of sunshine, and you never shovel, and the food is cheaper.” Vicki pipes in with great satisfaction, “It's farm to table food.”

Anderson was born in Northern Minnesota and became a Local 1 member in 1956, the same year he married his wife LaVonne, now a retired teacher. One year later they move to East Grand Forks, MN. They have two sons, three daughters, 11 grandchildren and 10 great-grandchildren. For more than 30 years Anderson and LaVonne were snowbirds. Today, LaVonne resides in a memory care facility.

In the beginning years of your career, you traveled where the work was, says Anderson.

But throughout the years, bricklaying has

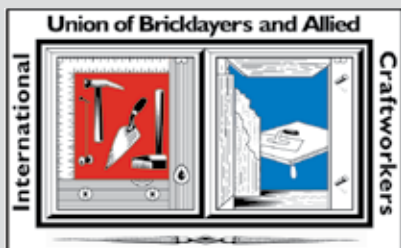
Annually in October, North America's Building Trades Unions hosts a conference for all Union Tradeswomen and their allies. We are in conversation with multiple contractors wishing to become signatory to BAC Local 1 and we will be working with an interested contractor in South Dakota on creating a concrete contract. Work opportunities are available for members and contractors in Rapid City, SD, with the large expansion project at the Airforce base and multiple infrastructure projects in this area.

We have a handful of negotiations that will take place in Grand Forks, ND, and Sioux Falls, Aberdeen, Watertown, and Rapid City, SD, in early 2023. under and some has gone nonunion without benefits. But when you are a union member, you retire healthier, happier and with money.

Two of Anderson's grandsons have followed in his lead; Trevor became a BAC Local 1 member in 2017, and his brother Dylan, in 2019.

On any given day at 4:30 am you can find Anderson driving the golfcart to the clubhouse to brew the day's coffee. Soon he'll share a cup or two with other RV park retirees. "You can sit on your rear or do whatever you want," says Anderson about retirement. "You take it as it comes." An avid reader, Anderson also trades books. His favorites include Westerns, legal thrillers and authors Zane Grey and Louis L'Amour. He reads about one book a week and his current read is *The Wrong Side of Goodbye* by Michael Connelly.

While in Minnesota during the summer months, Anderson takes care of paperwork, accounting and Medicare, including some work on the farm. He also spends time with his grandchildren and great-grandchildren.

The "92-years-young" retiree misses the camaraderie of dining with the brotherhood. He encourages the members to not be

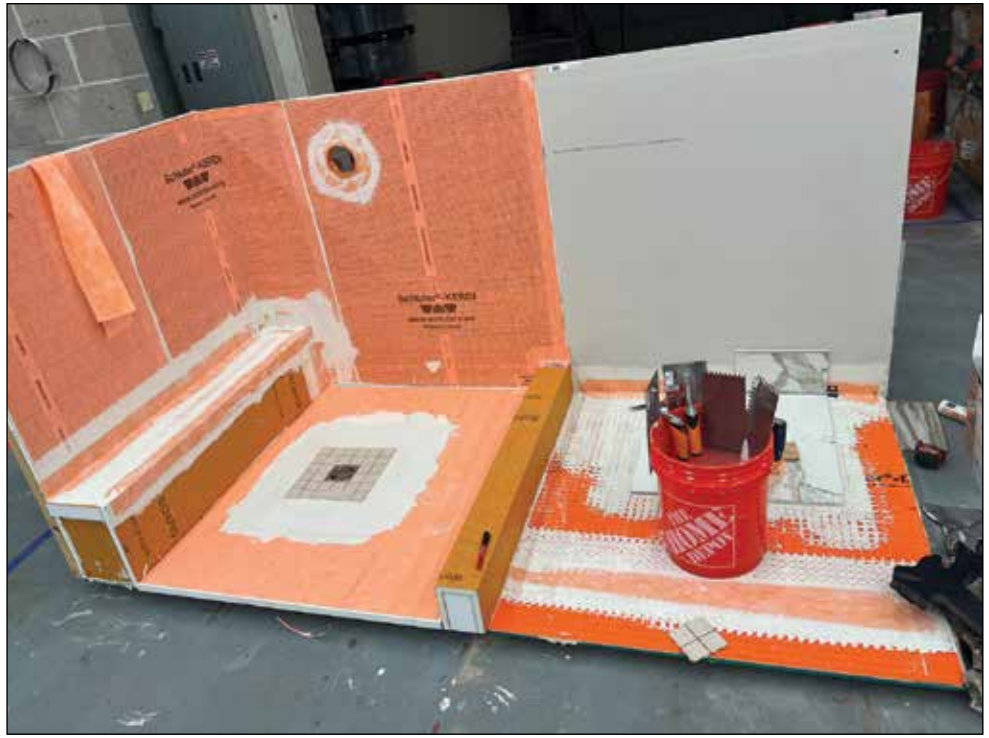
afraid of manual labor. "Too many people are being paid not to work. They don't appreciate working for the dollar," he says. "Get involved."

## BAC Highlights

In October, we had product representatives for Schluter Systems at the training center for two nights of hands-on demonstration featuring their uncoupling membrane and complete shower system. The uncoupling membrane is designed to reduce cracking in the subfloor and increase longevity of the tile by adhering to the subfloor and allowing the mortar bed to float. The complete shower system is an integrated system that is entirely watertight from the showerhead down when installed. It can include soundproofing, shower shelves, benches, and curbs.

In our training, they covered TCNA and ANSI specifications for waterproof membranes and shower pans. Our tile apprentices learned about the different mortars used with the products and the correct tools for use with the projects they created. They practiced proper troweling



techniques and measuring and cutting for precision fit. They built a shower bench and installed a drain using these systems and appropriate techniques, which was a great opportunity for all our apprentices to get hands-on experience on these installations.

A special thanks to Jeremy, Nick, and Brian, of Schluter Systems for the time they spent on the preparations, the successful two days of training, and the clean-up after.

Schluter Systems training will be available as an upgrade to all current tile journey workers. The next class is in January/February 2023 pending interest. A minimum of 12 sign-ups are required to schedule the class. Sign up here <https://www.bactraining.org> or call 763-404-8345.

## UPDATES FROM IMI NATIONAL

### IMI Working with TMS to Educate Designers on the Next Edition of the Masonry Code

The Masonry Society (TMS) published the next version of the masonry code recently, TMS 402/602- 2022. This replaces the 2016 version of the code which is just now being adopted by various states. While this version of the code won't become law for another couple of years, The Masonry Society, with the guidance and support of IMI, is educating designers on the new and updated provisions.

The biggest change to TMS 402/602 is the total rewrite of the veneer chapter in the code. IMI was the chair of the subcommittee charged with updating the veneer requirements. The chapter provides better guidance on the design and installation of adhered veneer and updated guidance on veneer tie spacing for anchored veneer. Tables now provide design requirements for veneers on cavity width, maximum veneer height and appropriate veneer tie type was added.

Other changes that have some larger impacts to designers, contractors, and craftworkers include:

- Grout spaces have been more clearly defined to take into account tapered block face shells and overlapping webs.
- The design of masonry beams was updated with better guidance on deflection requirements for the beams.
- More information on the use of single wire reinforcement was added to the code.
- Provisions for anchor bolts were updated with a new table on design provisions.
- Improvements to the prestressed masonry chapter were made with inclusion of new sections on the design of prestressed beams and lintels.

For more detailed information, IMI provided instruction as part of TMS's Night School, a five-part series that explained all of the changes that have occurred.

### Updates to Masonry Construction Software Help Contractors Deliver Successful Projects

Technology for construction is continuously evolving to meet the challenging demands of jobsites. Workflows using software and tools to assist with hands-on tasks empowers contractors and craftworkers to track materials, numbers, and to be more efficient and accurate. Contractors may find these new construction technology releases useful for their projects.

**MASONRY iQ BUILD** released an enhanced version of their masonry Revit plugin. This version is created specifically for contractors. Masonry iQ BUILD can create estimates from component level models, saving time crunching numbers. Masonry contractors can use Masonry iQ BUILD to model rebar, pull quantities, and tie cost to a masonry assembly, assisting with creating an accurate bid. **Bluebeam** released Bluebeam Cloud, a subscription-based plan that features a flexible markup editor for marking up and collaborating on project documents. It also includes field tools for managing and tracking punch items, RFI, and submittal workflows. Bluebeam Cloud and Bluebeam's markup editor Revu are offered together as a bundled subscription plan.

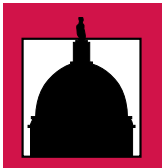

### A Pro-Labor State Government
